TUITION POLICIES

Tuition is payable in ten equal installments with the first non-refundable payment due in June. Payments are due the 1st of the month from August to May. There is no tuition payment due in January due to re-registration fees due. Late Payments made after the 10th will be assessed a \$20.00 fee. Returned checks will be assessed \$20.00.

Parish rate = registered members of St. Ambrose Church, using the envelope system, attending regularly, and honoring a financial commitment to the parish of a minimum of **\$800.00** per year (based on prior donation from May 1, 2007 to April 30, 2008).

30 service hours required per family each school year with mandatory participation in selling/purchasing school raffle tickets. Incomplete hours will be billed at \$10.00 per hour and price of tickets will be added to tuition accounts.

Curriculum Fees cover:

Consumable workbooks and supplies. Includes a \$50 book rental fee which will be put in escrow to cover future textbook purchases. Art, Music, Physical Education, Science Lab, and other supplies and materials provided during the year. Use of Media Center and resources. Standardization Tests. Premium for student's Accident Insurance during the school day. Printed materials distributed during the year.

Graduation Fees include robe rental, diploma, cover, program, flowers, mailings, awards and processing fees.

St. Ambrose School is pleased that you are considering registering your child at our school. However, it is our responsibility to remind all families interested in our school that the Immigration Naturalization Services **requires that a student hold a student visa(F-1) before they are allowed to attend classes in a school in the United States.** A school is not allowed to admit into the school a child who is in the country on a Tourist (B-1 or B-2) Visa. St. Ambrose School will assist a family wishing to change their child's status from a Tourist Visa to a Student Visa in whatever way possible. It often takes INS several months to process and approve such applications; during this period the student may not be registered or attend classes the school.
